**PROMOTION:** Full Throttle Hot Lap Giveaway

**DATES:** Entries will be accepted from Wednesday, May 8th – Friday, May 24th, 2019.

**HOW TO ENTER:** No purchase necessary to register. You must be at least 21 years old to enter and able to provide valid photo identification upon winning. Register at your participating Metro Detroit Chevy Dealership of choice on its kiosk.

Or you can mail a postcard to Metro Detroit Chevy Dealer Full Throttle Hot Lap Giveaway to Strive Creative at 23510 Woodward, Ferndale, MI 48220. All entries must be received by Friday, May 24<sup>th</sup>, 2019.

**WINNER SELECTION:** Winner will be selected by random drawing of all kiosk entries from participating Metro Detroit Chevy Dealerships, online, and mail-in entries. The LMA will notify each winner by phone call, text, or email at the LMA's discretion based on the contact information provided in the official entry. Entrants are solely responsible for providing accurate contact information. Winners must acknowledge acceptance of the prize to the LMA within 24 hours of the LMA's notification or will forfeit the prize. Entrants need not be present to win.

**PRIZES:** Ten (10) winners will receive two (2) Grandstand tickets to the Chevrolet Detroit Belle Isle Grand Prix on Sunday, June 2, 2019, One (1) parking pass in a TBD lot near Belle Isle, and One (1) pass to take a "Hot Lap" ride on Sunday, June 2nd at a TBD time on Belle Isle.
